UNRISD Strategy 2021–2025



Social policy plays key roles for economic production, social reproduction, redistribution of income and wealth, and protection against life and market risks. In addition, it can foster social cohesion and the enjoyment of rights. What UNRISD calls Transformative Social Policy—human rights-based, entailing democratic decision making, and working in tandem with economic policies—is essential to address the root causes of poverty, inequality and practices which are unsustainable, deliver on the 2030 Agenda for Sustainable Development, and support recovery from the Covid-19 pandemic that is inclusive and sustainable for all.

The Transformative Social Policy programme analyses drivers and actors in social policy reforms. It is concerned with the role of social policies in overcoming inequalities, poverty and social exclusion, and in building towards a new eco-social contract which delivers universal social rights and environmental justice. It uses a political economy lens to examine institutional and political contexts from local to global levels, and to unpack the role of policy decision makers, civil society and private sector actors—from elites to progressive alliances and social movements. The programme aims to better understand the drivers of inequality and its attendant fractures, and to identify policies that produce more equitable development outcomes.

Research credibility, thought leadership and extensive networks generating significant, long-term transformative impacts.

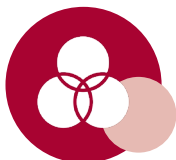

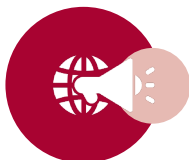
